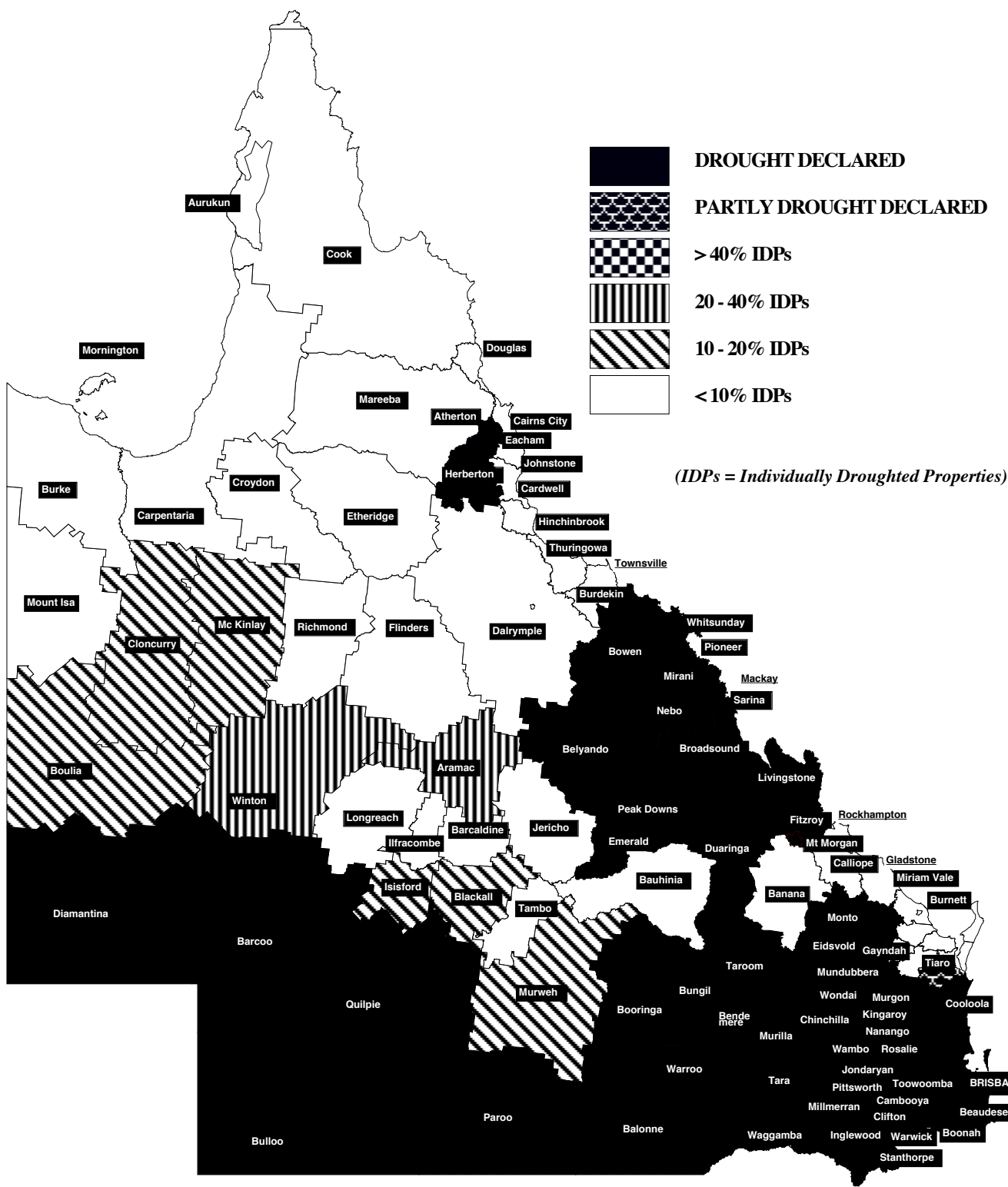

From Blair Athol the boundary follows the Blair Athol bypass road to the Clermont - Laglan road which is followed to Dunda Creek. Dunda Creek is followed south west to the Jericho Shire Boundary.
