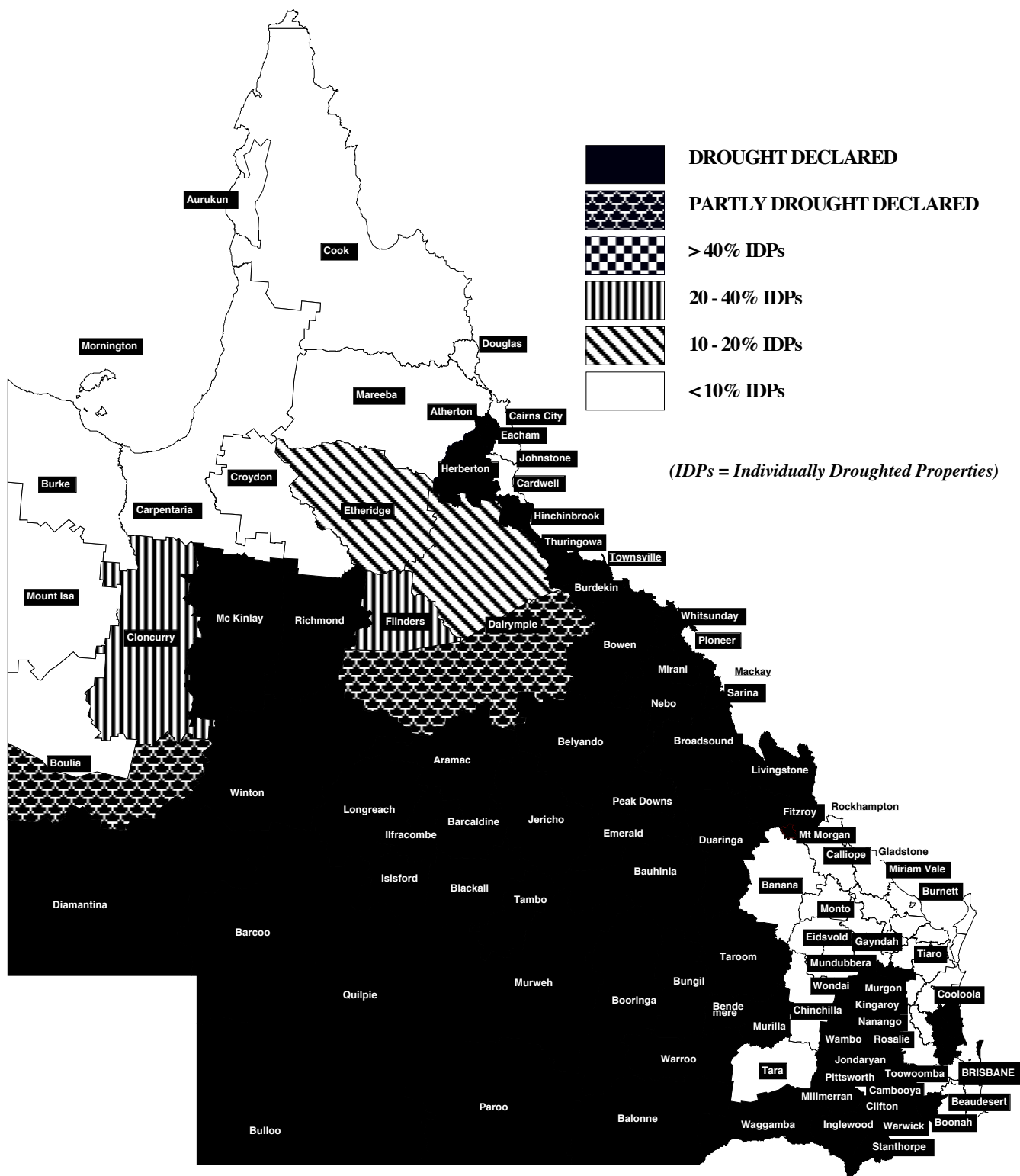

- ◆ The remainder of the shire of Taroom not covered by the 26.07.2001 declaration.
- ▲ That portion of Quilpie Shire located south of the Charleville to Quilpie Road and then to the south and west of the Quilpie to Windorah Road.
- The remainder of the shire of Quilpie not covered by the 01.09.2002 declaration.
- ▶ That part of the shire of Belyando covering the area south of the following boundary: The Goonyella road from the Nebo Shire boundary to Goonyella and then south along the Moranbah - Goonyella road to the Blair Athol rail line, which is followed south to Blair Athol. From Blair Athol the boundary follows the Blair Athol bypass road to the Clermont - Laglan road which is followed to Dunda Creek. Dunda Creek is followed south west to the Jericho Shire Boundary.
- ◆ The remainder of the shire of Belyando not covered by the 12.11.2002 declaration.
- ✖ The area of Boulia shire east of the Diamantina Development Road and south of the Donohue Highway.
- ◆ That part of the shires of Flinders, McKinlay, Dalrymple and Richmond south of the Flinders Highway.
- The remainder of the shire of McKinlay not covered by the 31.01.2003 declaration.
- * The remainder of the shire of Richmond not covered by the 31.01.2003 declaration.
